### Green Guide Tips

Simple How-To's for using the Guide effectively

#### How To Use the Green Guide™ and LEED® in Concert

**Join the Pilot and take part in the on-line Forum.** Joining the Pilot is free! Work out solutions to barriers to implementation for certain strategies with your peers in a private, anonymous list-serve. Participation in the Pilot gives design teams, facility managers, and owners access to the on-line Forum, an interactive list-serve designed to allow participants to share implementation strategies, ask questions, and build knowledge about each credit. There is no similar list-serve for health care projects in the LEED program.

**Don't reinvent the wheel.** A number of LEED credits have been modified in the Green Guide to address issues specific to hospitals. One simple example of this is the Green Guide credit dealing with monitoring Indoor Air Quality during Construction. While the credit intent and requirements are the same as in LEED, the documentation requirements have been modified to align with ICRA (Infection Control Risk Assessment) protocols that health care owners now use to limit construction impacts in occupied buildings. Over the Pilot program period, design teams will receive updated list-serve postings about the acceptance of such credit modifications within the LEED framework.

**Mine the Green Guide for Innovation credits.** Unique Green Guide credits may assist design teams in defining and achieving Innovation Credits, which comprise up to 4 points in the LEED rating system.

**Help shape the future of green healthcare.** The Green Guide Pilot is a key foundation document for the LEED for Healthcare Application Guide. Owners and design teams actively engaged in health care projects that are utilizing the Green Guide can help shape it through participation in the Pilot. The Green Guide Forum provides the best venue for industry input into the value of modifying LEED-NC with healthcare-specific new credits as well as the challenges of achieving them. The LEED Application Guide committee is monitoring the Green Guide Forum closely to help define the future direction for health care in LEED.
