### Green Guide Tips

Simple "How-To's" for Using the Guide

#### How To Fundraise for Cutting Edge Green Design Strategies

A recent internal poll revealed that only 15% of *Green Guide for Health Care*™ Pilot projects have applied for grants or incentive programs to help fund their green initiatives. Many poll participants were unaware that funding opportunities accommodate and, in some cases, target institutional and health care facilities. This edition of "Green Guide Tips" is designed to dispel the myth that green building grants and incentive programs are unavailable to health care projects.

In many ways, fundraising is a local issue. Some utilities, for example, have established incentive and rebate programs that encourage institutional and health care facilities in their jurisdiction to implement energy efficiency measures. In other cases, private foundations support green building in specific regions of the country. The two Pilots listed below, Denver Health in Colorado and Howard Memorial Hospital in California, demonstrate the variety of opportunities that are available: ranging from eco-charrettes and efficient technologies to support for research and innovative programs.

*Denver Health* was granted \$20,000 for their new Women's and Children's Pavilion in order to hire a high-performance design specialist to facilitate an integrated design process and oversee the LEED approach. The money was funded through the Governor's Office of Energy Management and Conservation's Rebuild Colorado program.

The *Howard Memorial Hospital* kicked off its fundraising campaign by initiating a dialogue with community stakeholders about the value of sustainable design, construction, operations, and clinical programs. Strong community support for the project has led to donations from a combination of private and public foundations, government sources and industry. Their green building fund supports a variety of efforts, including the integrated design process, energy efficiency measures, and an on-site organic vegetable garden that will supply the hospital's kitchen.
