Green Guide for Health Care Version 2.2 is Here!

The *Green Guide for Health Care* Steering Committee is pleased to announce the release of Version 2.2. A project of the Center for Maximum Potential Building Systems and Health Care Without Harm, *Green Guide* Version 2.2 boasts a substantially revised *Construction* Section and several clarifying changes to the *Operations* section. The most significant revisions respond to feedback from *Green Guide* Pilot projects and, where appropriate, align with LEED for New Construction Version 2.2. Representing more than 30 million square feet in the U.S., Canada, and internationally, the 115 Pilots represent a broad cross-section of health care construction relative to location, scale, and facility type. All document revisions were thoroughly researched and peer-reviewed before being approved by the *Green Guide* Steering Committee. Green Guide Construction Section Substantially Revised

Added to *Green Guide* Version 2.2 *Construction* Section are one mandatory Prerequisite (now 12 total prerequisites) and one voluntary Credit (now 97 total credits). These changes, along with consolidation of several existing credits, has resulted in a slight shift of credit weighting across sections.

A handful of credits have been consolidated in *Green Guide* Version 2.2:

GGHC v2.1 WE Credit 1.1: Water Efficient Landscaping: Reduce Potable Water Use by 50% was removed in response to the concern that landscaping accounts for a small percentage of total potable water use in most U.S. health care facilities. GGHC v2.1 WE Credit 1.2: Water Efficient Landscaping: No Potable Water Use or No Irrigation was renumbered WE Credit 1 to encourage reuse of on-site rainwater and process water as well as municipally-provided reclaimed water for irrigation purposes.

GGHC v2.1 EA Credit 6: Energy Supply Efficiency was removed to reflect the USGBC's Administrative Guidance for LEED-NC EA Credit 1, providing a calculation for projects tying into a Combined Heat and Power supply source. To offset removing EA Credit 6, two points were added to EA Credit 1: Optimize Energy Performance.

GGHC v2.1 MR Credits 3-7 were consolidated into the single, five point credit, GGHC v2.2 MR Credit 3: Sustainably Sourced Materials, recognizing the need to consider multiple criteria when specifying building materials for the health care setting.

GGHC v2.1 EQ Credit 8.2: Daylight & Views: Building Orientation was deleted because the benefits of optimal building orientation are addressed in the Energy Optimization credit GGHC v2.2 EA Credit 1, and in GGHC v2.2 Daylight & Views Credit 8.1: Daylight for Occupied Spaces.

GGHC v2.1 EQ Credit 8.3: Daylight & Views: Views for Occupied Spaces was changed to Connection to the Natural World: Indoor Places of Respite to emphasize the significance of incorporating views that promote healing.

Several new credits have been introduced to *Green Guide* Version 2.2:

GGHC v2.2 SS Credit 3.3: Brownfield Redevelopment: Minimizing Future Hazards – The language covering site infiltration in GGHC v2.1 SS Credit 3.2 was moved to its own credit.

GGHC v2.2 SS Credit 5.3: Site Development: Structured Parking – This new credit ties on-site habitat protection to the inclusion of structured parking in lieu of surface parking.

GGHC v2.2 SS Credit 9.2: Connection to the Natural World: Exterior Access for Patients – This new credit expands the reach of outdoor places of respite to inpatient and outpatient units.

GGHC v2.2 EA Credit 6: Green Power – Four points were added to the Energy & Atmosphere section to encourage health care facilities to purchase electricity from renewable sources.

GGHC v2.2 EQ Prerequisite 2: Environmental Tobacco Smoke Control (ETS) - This Prerequisite was added to the Construction section to align with LEED for New Construction v2.2.

GGHC v2.2 EQ Credit 9.2: Acoustic Environment: Sound Isolation, Paging & Call System, and Building Vibration – GGHC v2.1 Credit 9 was revised to reference the Draft AIA/AHA Interim Sound and Vibration Design Guidelines for Hospitals and Healthcare Facilities. Responding to the length and comprehensive nature of the reference standard, the credit was divided into two parts to align the level of effort required for credit achievement with other *Green Guide* credits.

After the Pilot

The roll out of *Green Guide for Health Care* Version 2.2 marks the end of the Pilot program and the next step in the *Green Guide's* evolution. Projects currently enrolled in the Pilot are encouraged to remain active participants in the *Green Guide* community. Pilot projects will automatically be re-registered as *Green Guide* Version 2.2 projects. Registration for *Green Guide* Version 2.2 projects will open to the general public in March 2007. All projects using the *Green Guide* are welcome to register and to participate in building a body of knowledge on current best practices in the green health care design, construction and operations industry.

Website

Updates to the *Green Guide for Health Care* website (www.gghc.org) are underway, due to be released in March 2007. Upgrades will include a new Forum, the ability for project team members to access *Green Guide* project information, and expanded access to online project administration.
