### The NEW Green Guide for Health Care Website

Earlier this month, the *Green Guide* re-launched its website, aligning with *Green Guide* Version 2.2, and enhancing online services. Read on to learn about the new capabilities of the *Green Guide* website.

#### Improved Site Navigation

The *Green Guide* homepage has been streamlined to highlight upcoming events. Help us keep the Events calendar current by sending information about green health care events to [info@gghc.org](mailto:info@gghc.org).

The new website also offers improved access for website registrants interested in downloading the *Green Guide* v2.2 or other educational information, accepting an invitation to join a *Green Guide* registered project team, and learning more about the *Green Guide for Health Care* document and organization. As soon as you log on, you will be directed to a personalized splash page with direct links to available web tools. The more active you become in *Green Guide* work, the more links will become available.

#### Enhanced Online Registered Project Management Tools

Beginning in March 2007, *Green Guide* project registration is free and voluntary. All projects that were *Green Guide* registered pilot projects are automatically registered. We encourage all projects tracking the *Green Guide* to register as Version 2.2 projects to take advantage of the new online project management tools and to take part in Forum discussions.

In the *Green Guide* Pilot, only *Green Guide* project managers had access to project details. The new, enhanced website configuration provides all project team members with read-only access to the online checklist and project information. The new *Green Guide* Version 2.2 checklist allows teams to assign responsibility for specific credits and provides a text box next to each credit to note the strategies employed to comply with credit goals.

*Green Guide* project administrators maintain editing privileges over the project information. However, by granting read-only access to the entire project team, project administrators can improve coordination among team members, leading to a more successful integrated design process.

In addition, more than one project administrator can now associate with *Green Guide* registered projects. This new feature will allow, for example, the project architect to manage *Construction* section credits while a representative from the health care organization manages credits in the *Operations* section. All registered project team members continue to have free access to the online Forum, a private peer-to-peer list-serve of professionals and health care providers. The Forum allows project teams to ask questions about *Green Guide* credits and share solutions with each other in a safe, anonymous environment.

#### GGHC Version 2.1 Data

The updated *Green Guide for Health Care* website is tailored to align with the *Green Guide* v2.2's revised *Construction* section. Many components of the website, most notably project checklists and the online Forum, were therefore greatly modified during the course of the website update. These superseded *Green Guide* Version 2.1 tools have been archived and continue to be available to project team members in a read-only format.
