Green Guide for Health Care™ Joins Practice Greenhealth

The *Green Guide for Health Care* (GGHC) and longtime collaborator Hospitals for a Healthy Environment (also known as H2E) are joining forces with Healthcare Clean Energy Exchange, a new program aimed at reducing both energy costs and a facility's carbon footprint, to create a new nonprofit member-based organization, **Practice Greenhealth**.

Green Guide for Health Care™ (GGHC) – the first and only voluntary best practices toolkit for the design, construction and operation of health care facilities, offering a “one stop shop” for implementing healing design features, effective energy and water strategies, safer materials and responsible materials management.

Healthcare Clean Energy Exchange™ (HCEE) – a reverse auction program (currently in pilot stage) to assist healthcare providers in lowering energy bills while increasing the percentage of clean energy in their energy procurement portfolio.

Hospitals for a Healthy Environment™ (H2E) – a national, not-for-profit knowledge organization with 10 years experience providing tools and resources to support environmentally sustainable health care facilities.

Practice Greenhealth will offer a full range of tools, resources, and strategies for achieving environmental excellence in health care. The new organization – based on the understanding that protecting the environment is a health imperative – has been formed in recognition of the huge strides made by the health care industry toward establishing a sustainable health care sector.

The new organization will build on the successes of joint GGHC and H2E programs integrating green building and green operations into a comprehensive approach to environmental excellence. GGHC and H2E will combine our constituency populations – inclusive of the full spectrum of professions connected to health care construction and operations – into a single source, comprehensive learning community to distill and disseminate news, knowledge, and emerging trends.

- The Healthcare Clean Energy Exchange program exclusive to Practice Greenhealth members will help facilities cut energy costs between 6-12%, while reducing its carbon footprint.
- Strategies and services will assist project teams and health care facilities achieve the design, construction, and operation of high-performance healing environments, as defined by the *Green Guide for Health Care*. The *Green Guide* is a foundational document for the U.S. Green Building Council's LEED for Healthcare third party certification rating system, due to launch this year.
- Tools and resources including a subscription-based Webinar series focused on both Design & Construction and Operations, peer networking events, a Waste Data Tracking Tool, national Environmental Excellence Awards, a Business Alliance, and much more.

As more programs, initiatives and standards unfold, Practice Greenhealth will act as a catalyst to accelerate the health care sector's transformation into a leader in environmental excellence. We invite you to be part of this journey.
