Green Guide for Health Care™ Operations Section Update

The *Green Guide for Health Care* (GGHC) is concluding a review and update of the *Operations* Section. Over the past six months, a committee of professionals representing a broad spectrum of health care sector perspectives has collaborated with technical experts and representatives from membership organizations such as the American Society for Healthcare Environmental Services (ASHES) and the Association for Professionals in Infection Control and Epidemiology (APIC) to conduct a major overhaul of the tool.

The *Green Guide for Health Care*, a project of the Center for Maximum Potential Building Systems and Practice Greenhealth established in 2002, is the first voluntary, best practices green building toolkit customized for the health care sector, using the U.S. Green Building's LEED® credit framework, with permission. To date, the *Green Guide* has attracted more than 17,000 website registrants, and 150 registered projects representing more than 34 million square feet of green health care facilities in the U.S. and abroad.

The *Green Guide Operations* section's updated mandatory prerequisites and voluntary credits emphasize continuous improvement and frame best practices in operations and maintenance protocols, keeping abreast of the momentum in policy and practice towards green building methods and materials. These strategies yield measurable improvements in enhancing the facilities' health and environmental performance. Roughly 60% of GGHC registered projects have pursued or are pursuing the *Operations* section in tandem with new construction, additions and renovation projects. However, the *Operations* section can also stand on its own as an independent tool.

The GGHC *Operations* review committee has set the following goals for the updated *Operations* toolkit:

- **More user friendly** – Reorganize the tool to group strategies by facility department.
- **Up to date** – Update regulatory standards, best practices, and resources to the most current available information. Align with the 2007 revision of LEED® for Existing Buildings-Operations and Maintenance, where applicable.
- **Expanded scope** – Reflect emerging priorities in health care operations and maintenance, such as emissions reporting, low-impact grounds maintenance, sustainable food service, and multi-attribute environmentally preferable purchasing policies.
- **Emphasize continuous improvement** – The self-certifying nature of the GGHC lends itself to continuous improvement. The revised *Operations* section emphasizes goal setting and establishing ongoing environmental programs by requiring periodic performance evaluations and outlining aspirational innovation points for industry leaders.
- **Emphasis on Integrated Operations and Education** – Strengthen requirements focused on establishing a cross-departmental structure governing environmental programs and emphasizing ongoing education of staff, patients and visitors, and the general public on the connection between greening a facility's operations and human health.

Due to the extensive nature of the GGHC *Operations* review process, the revised toolkit will be released for a 30-day public comment period prior to its official launch.
