Participate in Second Public Comment Period for 2008 Revised GGHC Operations Section

Review and comment on Credit modifications implemented in response to the first round of public comments.

The most significant revision to the *Green Guide for Health Care Version 2.2 Operations* section to date has undergone a further set of refinements. In response to the over 350 public comments received during the first public comment period, 43 credits have undergone revisions to the Intent statement and/or Credit Goals and are published for a Second Public Comment period.

Building on the experience of the *Green Guide's* roster of registered projects, a volunteer committee of professionals representing a broad spectrum of health care sector perspectives and technical experts, the update **emphasizes continuous improvement and frames best practices in operations and maintenance protocols**, keeping abreast of the momentum in policy and practice towards green building and operations methods and materials. These strategies yield measurable improvements in enhancing a facility's health and environmental performance.

How to Participate

1. Go to <http://www.gghc.org>
2. Click on "login"
3. Log into the website
4. Click on the "Downloads" button to download the revised Operations section in the 2008 GGHC Ops Revision-2nd Public Comment folder.
5. Return to the landing page and click on the "Public Comment" button. *Please note that the public comment page requires a separate website registration from the GGHC website.*
6. After you have registered on the public comment page, log in and click on the appropriate section and credit link. Note that only credits modified in the Intent and/or Credit Goals sections are included in the Second Public Comment Period. Closed credit posting are listed as "Closed" on the public comment website. However, all responses to the first round of public comment are publicly available on the public comment website.
7. Post your comment.
